EARL SHILTON TOWN COUNCIL MINUTES OF A PLANNING COMMITTEE MEETING

Chairman's welcome and opening remarks. 20/020

> The Chairman greeted colleagues, thanked them for attending this virtual meeting and then proceeded to the agenda.

Noted and received.

To receive apologies for member absence. 20/021

> Clirs Mrs C Coe and Ms J Duplock gave advance notice of their apologies for absence in writing with a good reasons as recorded by the Town Clerk. During the meeting it became apparent that Cllr B Granger was having Zoom connection issues and so, de facto, gave his apologies for absence. Resolved: to accept the said Clirs apologies as tabled and recorded.

- Declarations of interests. To receive disclosures of member's interests, i.e. the 20/022 existence and the nature of those interests in respect of items on this agenda. None. (See minute 20/024 a. regarding the need for Borough Clirs requiring not to fetter their discretion regarding this potential application).
- To receive and approve as a true record the minutes of the Planning Cttee 20/023 meeting held on 01 September 2020. Resolved: to accept as a true record, the minutes of the meeting of the 01 September 2020 as tabled and circulated to members prior to the meeting.
- Planning applications/correspondence received as a Town Council 'statutory 20/024 consultee' from HBBC, adjacent Districts and or LCC as Local or County Planning Authorities (LPAs) respectively or relevant source, for the following:
 - a. Marlpit Farm Thurlaston Ln. Boyer/Persimmon re: 109 dwellings.

Point of order: Clirs C and R Allen are also Borough Clirs and members of that 'Local Planning Authority' (LPA) Planning Cttee who will decide matters for any such major housing application. Therefore as this agenda item is not a formal application to be discussed in terms of ESTC Consultee Comments both Cllrs



Allen will only state non-partisan points of fact so as not to fetter their discretion in any future formal proceedings.

Discussion points to note about this consultation offered to local residents close to Marlpit Farm were as follows:

- Residents of King Richards Hill are taking a particular interest in proposals and are contacting both Clirs Allen in respect of the matter to enquire as to its status: legal and otherwise.
- The site archaeological works already carried out by contactors have exceeded their remit and have been subject to Borough Council Enforcement Officer restraint to halt further works.
- The residents' consultation from Boyer/Persimmon which has now closed 'is what it is' and not a formal planning application. A factual <u>outline</u> or <u>full</u> application will reveal more details but be subject to change in any case.
- In 2010 singleton developer planning permission for this site was refused as the application did not fit in with the planned Earl Shilton Sustainable Urban Extension (ES SUE) of which it was deemed to be a part. The current status of the ES SUE and Marlpit Farm is not clear at this time.

b. 20/00411/FUL - 23, Masefield Dve - new hard driveway vehicle access on to Breach Ln.

Despite repeated cogent objections from the Town Council and Earl Shilton County/Borough Cllrs, the HBBC LPA Planning Cttee meeting of 29 Sep 20 'granted' planning permission for this new vehicular access on to Breach Ln from a Masefield Dve property with perfectly suitable vehicle access. Not without regret members acknowledged that without a formal right of appeal under current general planning regulations any barrister led legal challenge would likely result in an expensive failure at cost to the taxpayer.

c. 20/00871/REM –Field View, 2 dwellings; re reserved matters application 18/01191/OUT.

d. 20/00965/TPO – Earl Shilton Town Council Borrowdale Close Public Open Space (POS): felling of 7 poplar trees.

After a recent independent professional Town Council parks, cemetery and POS tree survey Council reluctantly have taken the advice that these 7 trees are now unsafe and must be felled. When all tree felling on Town Council properties has been concluded as per the survey, through this Cttee Chairman members expressed the wish that more of and more suitable trees be planted as soon as possible to compensate for the losses.

Noted and received – (application on behalf of the Town Council itself). e. Blaby District Council – 20/0835/RM – Stoney Stanton Business Park.

Members received a tabled 'Consultee Objections' paper dated 09 Sep 20 written and a copy sent to the Town Council by Stoney Stanton Parish Council



(SSPC) which has been submitted to Blaby District Council as that local council's LPA. Issues regarding surface and foul water are clearly an ongoing matter as are highways access, for larger vehicles, and volumes of traffic with potential knock-on effects to adjacent settlements with other major development proposals in mind also. Cttee members, in principle, if a formal request for support comes from SSPC are strongly minded to be behind some of the objections. Actions-on: the Cttee Chairman requested that the Town Clerk make available to members application 20/0835/RM - Stoney Stanton Business Park as soon as possible so as to have the actual application detail of the SSPC submission paper of objection to hand.


